American Rescue Plan Act (ARPA) – State and Local Fiscal Recovery Funds (SLFRF) – Use of Force Training Grant (UOFTG)

#### **Introduction:**

The Missouri Department of Public Safety is pleased to announce the funding opportunity for the ARPA SLFRF Use of Force Training Grant (UOFTG). This state administered, but federally funded program, is made available through the U.S. Department of the Treasury and appropriated through Missouri House Bill 20 Section 20.572.

#### **Program Description:**

The purpose of the ARPA SLFRF Use of Force Training Grant (UOFTG) is to provide grant funding for law enforcement training on the proper use of force, de-escalation, and constitutional policing provided by a basic training center or a continuing law enforcement education training provider licensed by the Director of the Missouri Department of Public Safety. Such training shall be made available to all Missouri law enforcement officers.

**Projected Period of Performance Start Date:** 01/01/2024

**Projected Period of Performance End Date:** 06/30/2026

\*\*Costs obligated or incurred prior to the grant period of performance or receipt and full execution of a grant Subaward Agreement will NOT be eligible to receive funding.\*\*

**Maximum Award:** \$1,000,000.00 maximum award per applicant agency. Funds in the amount of \$1,000,000.00 are available for this program.

#### **Eligible Cost Items:**

The Missouri Department of Public Safety's objective in awarding ARPA SLFRF UOFTG funding is to provide law enforcement training on proper use-of-force, de-escalation, and constitutional policing. Eligible costs may support personnel, benefits, travel/training, equipment, supplies, and/or contractual expenses that are necessary to provide the training. ARPA SLFRF UOFTG grant funds **CANNOT** be utilized for costs that have been obligated or incurred <u>prior</u> to the grant period of performance. The project grant period of performance begins **January 1, 2024**. In addition, supplanting is **NOT ALLOWED** for the ARPA SLFRF UOFTG. Supplanting occurs when an entity reduces funds that have been budgeted for an activity/project, specifically because grant funds are available.
