## • <u>Legislative Report – Steve Sokoloff</u>

There are four bills currently in the legislature impacting the 911 system.

HB1904 – 911 Cell Phone Tax has been voted out of the House but has not been assigned to a Senate Committee.

SB871 – is the companion bill in the Senate and has some language in regards to Taskforce One. It has been voted out of committee recommended "do pass" but it is not formally reported out or read.

SB895 – provides for tax increment funding. It has been voted out the Economic Development Committee recommended "do pass" but it is not formally reported out or read.

HB2102 – Strictly pertains to Taney County. It is voted out of the House Committee, has been reported out, but has not been put on the calendar.
