Most all the students advised this is a more effective way to inform students of the dangers and consequences of drug use. Because low self-esteem leads to the inability to resist the temptation. Their criminal activity created a debt to society, which participation in the school programs allows them to pay back their debt to society.
LANEG	Yes LANEG TFO'S were contacted by Missouri Probation and Parole Officers who had requested assistance with approximately 12 home visits of individuals currently under supervision for drug related offenses in counties of Crawford, Laclede and Osage and the city of Lebanon. The purpose and benefit to the probation/parole and LANEG was twofold. 1) It allowed the P/P officer to conduct home visits on subjects who they believed were relapsing and involved in illegal drug use or sales. 2) It served as a reminder to subjects on P/P, that the supervising officer will attempt to verify a subjects home and employment status as reported by the subject in their monthly office visits. We struggle with keeping up with the tips and confidential informants with only a few investigators.

CNET

CNET had three TFO's attend MSHP clan lab school during this reporting period and all six TFO's attended a week long basic narcotics course taught by DDCC during this reporting period also.

COMET

COMET gave a drug presentation to 52 people of the Probation and Parole in Christian County. A drug presentation was also given to 50 people with the Junior Auxiliary in Taney County. A methamphetamine lab presentation was given to 32 employees of Cox South Hospital. COMET has eight officers serving nine counties and has started to initiate long term investigations to make a greater impact on our service area.

EAST CENTRAL DTF

Our Task Force has continued to provide the services our member agencies have grown to appreciate and expect from our Task Force. Our Task Force continues to conduct overt narcotic investigations in our six county coverage area. Our Task Force continues to assist with several Federal investigations, providing information and with active enforcement. Recently, our Task Force conducted warrant round-up operations with our participating member agencies. The warrants were the culmination of prior narcotic investigations from the different counties in our Task Force coverage area. Overall, over seventy individuals were charged with numerous felony drug related charges. As a result, numerous individuals, who were suspected in the distribution of narcotics, were removed from the communities in our Task Force coverage area. The Task Force has also conducted drug educational and drug preventative presentations to civic organizations, law enforcement agencies and for schools in the communities for our coverage area. The topics of those presentations ranged from drug identification and awareness, and Highway Interdiction.

FRANKLIN CO NARC

We continue to battle the heroin epidemic in the Franklin County Area. We have partnered with the DEA in a new initiative to combat heroin use and abuse. This initiative not only focuses on enforcement, but education and rehabilitation as well. We are partnered with St. Louis and St. Francois Counties in this initiative as well. 'ICE' methamphetamine continues to be an issue in our area as well. We have made several large seizures of ICE during the quarter with ties being made back to source cities back into Mexico These investigations are continuing. We continue to locate and destroy methamphetamine laboratories, at a drastically reduced number, in the Task Force Area.

JACKSON CO MJDTF

In October, 2014 The Jackson County Drug Task Force (JCDF) in cooperation with the Federal Bureau of Investigation initiated an investigation into a group that was distributing large amounts of methamphetamine and illegal weapons in Jackson County and the Kansas City metropolitan area. A short time later Detectives were contacted by a Homicide Detective from KCPD. The Detective was investigating the murder of a known upper level methamphetamine dealer, who was murdered during a drug transaction in the laundry room of his apartment building. Three suspects were caught on videotape in the parking lot of a restaurant across the street from the homicide scene minutes after the homicide. One of those suspects was the main target of the JCDF investigation. The JCDF met with KCPD, the Bureau of Alcohol and Firearms, the Federal Bureau of Investigation and the Assistant United States Attorney in Western District of Missouri to coordinate the investigation of the JCDF target in the KCPD homicide. Based on information obtained as a result of the JCDF drug investigation two suspects were indicted by a Federal Grand Jury for the KCPD murder.

JASPER CO DTF

In January Task Force Officers arrested Vincent Soto at the Westwood Motel in Joplin he was in possession of 2 ounces of ICE. On 01/14/16 Task Force Detectives worked with Carthage Police Officers and seized over 1 pound of meth from a suspicious package that was turned over to USPS. On 01/20/16 Task Force Detectives arrested Jesse Hernandez and seized 107 grams of ICE. On 01/25/16 Task Force Detectives stopped Ray Asher in Joplin and seized 87 grams of ICE and 2 guns. On 01/26/16 Task Force Detectives Arrested Elvis Rodus in Duquesne he was in possession of 14 grams of ICE. In February Task Force Detectives attended a week long Basic Narcotic Class in Joplin then went to Nashville for a week long Advanced Narcotic Class. On 02/04/16 Task Force Detectives served a search warrant in Jasper County and seized a meth lab. Task Force Detectives seized approximately 114 grams of ICE in the month of February. On March 1 Task Force Detectives served 2 search warrants in Joplin arresting 6 people total. On 03/13/16 Task Force Detectives arrested Lisa Lee 21 grams of ICE and \$10,000 USC. The end of the month Task Force Detectives attended the MNOA Conference at Loz. Task Force Detectives seized a total of 521 grams of ICE this quarter and served 18 Search Warrants. Five defendants were indicted federally by DEA and ATF which originated from ODET cases. Those defendants are Santiago SOTO, Destiny O'BRIEN, Christopher GONZALEZ, Jesse HERNANDEZ, and Elvis RODAS. O'BRIEN estimated that her organization had sold over 100 lbs of methamphetamine in the Joplin metropolitan area in 18 months. Future federal indictments may be forthcoming on ASHER and his wife Ronnie ASHER. ODET case Operation Shape Shifter (WC-MOW-0308) was approved on January 16, 2016 which included ODET.

KANSAS CITY MJDTF

MoWin task force has seen an increase in the trafficking of Cocaine during the 3rd quarter. The task force recovered 20 lbs of cocaine during this quarter alone. Additionally, 35 lbs of meth, 430 lbs of Marijuana and 14.5 Liters of PCP were recovered. On March 3rd K-9 officers assisted the Postal Service in a presentation for a high school group called Blue Valley CAPS. The presentation included a K-9 demonstration and summary of the work of the Interdiction Section. There were 20 high school students present at the class. K-9's conducted four sweeps of high schools during this quarter and in January, Springfield MO Police Department came to Kansas City to train with the Interdiction Squad. March 16th at the request of Marceline MO Police Department, two Kansas City detectives travelled to Marceline MO to advise and train officers in informant cultivation and general narcotics investigations. Clay County attended the Northland Safe Schools Coalition meeting in March. They discussed school drug trends and advised the group of what narcotics issues are prevalent in Clay County. The MoWin task force is part of the Clay County Drug and Veterans Court. The sergeant attends weekly meetings and assistance in the screening of drug court applicants. One of the detectives is a veteran's courts mentor and also attends weekly meetings. A donation was approved and given to the Clay County Drug and Veterans Court to be used at their discretion for program fees and testing. The Clay County Investigative Squad Board approved a donation of \$3200 to the Clay County Drug and Veterans Court Treatment Program. A donation of \$1800 was also approved for the Northland Coalition. The Northland Coalition is a local prevention group that specialized in drug and alcohol prevention programs. The donations were from the Clay County Investigative Squad Restitution Account. Members of the MoWin task force attended several training courses throughout the 3rd quarter. Clay County TFO's along with one Platte County TFO attended Managing and Cultivating Confidential Informants Class in February. Members of the task force also attended a user certification for the TruNarc Instrument. This is a new narcotics testing instrument we use in filing in custody cases. One detective assigned to the Clay County Tactical Team attended a breachers instructor school. In March, Clay County attended ALERT Active Shooter Training and MNOA. The sergeant attended the Missouri Association of Treatment Court Professionals. This conference is associated with all of the local Drug, Veteran, DWI and Mental Health courts in the state. Three Platte County TFO's attended the annual Missouri Narcotic Officers Association conference in March. Two Platte County TFO's attended New Detective/Investigator training, February 16-18th and one TFO attended an OMG sharing meeting in this quarter.

LAFAYETTE CO NARC

During the third Quarter of the 2015-2016 grant year, the Lafayette County Drug Task Force continued a balance between drug interdiction investigations and local drug investigations. Johnson County Narcotics Detective Aaron Brown and Warrensburg Narcotics Detective Trent Froebe both have contributed many cases and have helped supplement manpower shortage. They came on board and began making cases. The Lafayette County Drug Task Force maintained a 60 plus case load, which is what we reported last quarter. During this quarter, the Task Force organized meetings with all Pharmacy's within our MOU area, which include Lafayette, Ray, Carol, Saline and Johnson County. A total of 26 Pharmacies were contacted in person by a task force member who spoke with the pharmacists and staff about narcotic problems in their community. A lot of the Pharmacies did not realize the task force was a resource they had or could even call. Most all advised they are aware of prescription fraud and abuse but did not know what they could do. The task force explained what trends they saw on the street and gave all Pharmacies complete contact information for task force personnel. During this quarter, the task force organized and arranged to meet with the Lexington Rotary Club and spoke about drug issues in their community along with what law enforcement was doing to combat the problem. The organization was very receptive to law enforcement efforts and asked us to make sure we come back again and keep them updated on community issues. The Lafayette County Task Force arranged to meet with the Carrolton Missouri Police Department complete Staff in reference to narcotics investigations. Task Force officers provided training in cultivating informants and informant management. The Task Force also gave basic training in shake n bake meth labs along with how the police can make the public aware of the narcotics problems in their area. The Task Force organized and presented one drug awareness/education programs to the Lexington Missouri Wentworth Military Academy, which house students from all over the United States. The drug task force implemented and coordinated this school presentation, which involved law enforcement and the drug court 'STOP' program clients speaking to junior high and high school students, which consisted in about 150 students. The Lexington, Higginsville, Richmond, Warrensburg Police Departments all sponsor the drug take back programs throughout the year. As part of their contribution the program, they schedule these programs and the task force attends and assists. There were no drug take back programs this quarter but there are several take back programs scheduled for fourth quarter.

The presentation included signs and symptoms of common drugs of abuse and means available to intervene or report children or teenagers using illegal drugs, or individuals who may be potentially at risk due to their proximity to illegal drugs. LANEG has coordinated and worked with the Missouri State Probation and Parole in three counties within the task force area. This joint work approach has built up lines of communication between the agencies and has allowed for a better collection of intelligence, identification and intervention of illegal drug use in the task force area. These investigations target subjects at risk for substance abuse and/or sales who are currently assigned and supervised by the probation and parole within the task force area. This combined effort allows the agencies to identify subjects who may be better served by increased drug intervention programs or subjects who may need to be prosecuted in local courts. LANEG continues to focus its major efforts on combating the illegal drug trade in the five county task force area. The task force has scheduled and will continue to provide training to local agencies, schools and community groups about local drug trends and the impact of drugs on the community. Marijuana, illegal sales of prescription medication, and heroin sales remain present in certain areas of the task force but have not appeared to increase. The task force had an decrease in total number of abandoned meth laboratories seized during this quarterly reporting period. This decrease may be due to the availability of crystal methamphetamine and the proactive enforcement of assigned and trained task force officer in their assigned area of responsibility. Hydroponic marijuana and methamphetamine 'ice' sales and availability have appeared to increase in the task force area. LANEG officers continue to see a decrease in the sale of synthetic marijuana and bath salts by local distributors in the task force area. Confidential sources have informed our officers, individuals purchasing synthetic drugs are having to travel outside of the LANEG task force area. This decrease may be a direct result from aggressive investigations and local distributors being informed of the illegal nature and laws concerning the sales of synthetic drugs. LANEG is currently participating in follow up investigations and several ongoing federal and state investigations involving the distribution of crystal methamphetamine, hydroponic marijuana and synthetic drugs. LANEG officers have initiated and are currently involved in undercover investigations focusing on known drug distributors in the task force area. LANEG is currently working with and de-conflicting drug investigations with other task forces in the Troop F, D and I areas. Training programs to Law Enforcement on Butance Honey Oil Labs. Seized two pistols and 2 rifles. Fifteen other arrest which included felons in possession of firearms 3, child endangerment 3 and 9 felony arrests warrants.

MINERAL AREA DTF	During the reporting period an officer with the Mineral Area Drug Task Force purchased stolen property from a residential burglary during an undercover investigation. The officer established contact with a detective from that local agency and they are continuing the investigation at this time.
MUSTANG	The MUSTANG Drug Task Force applied and executed 24 search warrants in Cole County, Callaway County and Boone County. Search warrants resulted in the seizure of \$8,080.00 in US currency, and 2 firearms.
NEMO TF	The NEMO Task Force relocated to a new office location during this reporting period. The Task Force has been unable to fill an open position for a Special Agent and has been working with a short staff for many months.
NITRO	NITRO attended OIC meeting held in Kirksville, Missouri on February 10, 2016. Present, was representatives from the NOMO Task Force, the NEMO Task Force, NITRO Task Force and DPS. On March 16, 2016, NITRO met with the new OIC of the Buchanan County Drug Strike Force. In March 2016, a long term case, as brought to an end with the arrest of nine individual, nine search warrants, seizure of thirteen firearms, and the seizure of 17,800 grams of methamphetamine, 335 gr marijuana, 12.9 grams of cocaine, five vehicles and \$72,800 in cash. The case involved 19 purchases of three pounds of methamphetamine and thirty-nine firearms. A long term case came to an end with the arrest of the two major targets of the investigation. During the arrests there was over 600 grams of methamphetamine seized. NITRO assisted the Trenton Police Department with buys of marijuana and methamphetamine. The cases will be presented to a Grundy County Grand Jury in April 2016. It appears there will be thirteen individuals indicted for distribution of controlled substances. NITRO will have a long term case presented to a Federal Grand Jury in April 2016. It appears there will be ten individuals indicted. NITRO participated in a drug and alcohol summit held at Trenton, Missouri. The summit was attended by organizations from the Grundy County area. The purpose was to come up with a working plan to combat the drug and alcohol problem in the Grundy County area. Another meeting is planned for the last part of April.
NOMO DTF	OIC Meeting was attended by Capt. Chris Brown and Analyst Sally George on March 29th, 2016 at the Lake of the Ozarks, Missouri. NOMO has an ongoing investigation with the VanBuren County Iowa Drug Task Force dealing with the transportation of drugs and weapons across state lines. NOMO is compiling the information for the AUSA regarding a conspiracy case within our jurisdiction as a result of numerous interviews resulting from the pseudoephedrine pill logs. NOMO lost a Narcotics officer in December. NOMO was unable to replace that officer until February 2016. The new officer attended Lab School and is scheduled to attend Narcotics School in August. Unfortunately, bringing a new officer up to speed requires a great deal of time and training.

SEMO DTF	<p>An interview was conducted with KFVS Channel 12 (CBS affiliate) in Cape Girardeau about the synthetic cannabinoid problem and dangers associated with the use of those types of narcotics. An interview was conducted with the Southeast Missourian Newspaper in which the problems associated with distribution of crystal methamphetamine by Drug Trafficking Organizations was discussed. The dangers of methamphetamine usage was also discussed. The Department of Justice decision to cease in providing equitable sharing proceeds could have been a huge obstacle but the problem has been taken care of as of the end of March.</p>
ST CHARLES CO DTF	<p>SCCRDTF is continuing to seeing a large influx of 'ICE' and Heroin into our area. We have continued to aggressively pursue street level and mid-level drug traffickers in an effort to combat a rising problem.</p> <p>Once again JAG funding has been reduced and this impacts our ability to aggressively pursue drug traffickers in respect to operational funding. These types of investigations are labor intensive and require the involvement of all of the SCCRDTF's resources. As a result of long hours and no funding for manpower, due to reduced operational funds, we are forced with SCCRDTF resources having to take leave. Often this leave has a negative impact on the work product and our ability to pursue investigations. Increased funding would greatly aid in our efforts to remove dangerous narcotics from our community.</p>
ST LOUIS CO MJDTF	<p>SCCRDTF Detective/TFO Juan Wilson interviewed with Lindenwood University Television's Cassie Hall at the St. Charles City Police Department in St. Charles, Missouri, on the heroin epidemic in the community. SCCRDTF Detective/TFO Juan Wilson also did an appearance on KPLR 11 The Pulse to discuss the heroin epidemic and Jordan's Place (a teen center for the community) in Warrenton, MO. SCCRDTF Detective/TFO Juan Wilson interviewed with KMOV 4's Ray Preston at the St. Charles County Criminalistics Laboratory in O'Fallon, Missouri, on current heroin trends and prevention education.</p> <p>We started a Naloxone program in St. Louis County. Our Drug Task Force trained over 500 police officers, paramedics and nurses. In the first month after training began, six doses of Naloxone have been administered, saving four lives, proving this program to be very successful.</p>
