FY 2024 State Homeland Security Program – Counter Terrorism Officer (CTO) Equipment Grant

# Introduction

The Missouri Department of Public Safety (DPS)/Office of Homeland Security (OHS) is pleased to announce the funding opportunity for the FY 2024 State Homeland Security Program (SHSP) Counter Terrorism Officer (CTO) Equipment Grant. This state administered, but federally funded program, is made available through the Grants Programs Directorate (GPD) within the Federal Emergency Management Agency (FEMA).

# **Program Description**

The FY 2024 SHSP assists state and local efforts to build, sustain, and deliver the capabilities necessary to prevent, prepare for, protect against, and respond to, acts of terrorism.

The CTO Equipment Grant is available to any agency employing a member of the Missouri Office of Homeland Security Counter Terrorism Officer Program. The grant is for allowable equipment items up to a **maximum award amount of \$7,500.00**. In 2019 the Missouri Office of Homeland Security (OHS) began a process of analyzing gaps, in prevention, response, and mitigation of acts of terrorism, identified in the Threat and Hazard Identification and Risk Assessment (THIRA) across the 32 Core Capabilities. Through these assessments, OHS has identified a critical shortage in law enforcement officers trained to identify and plan for potential terrorist threats and vulnerabilities in our local communities. In order to expand law enforcement

capabilities in the areas of homeland security and to combat the rising threats of homegrown violent extremism and terrorist threats across the state of Missouri, the Counter Terrorism Officer (CTO) Program was designed.

CTO's are located within multiple jurisdictions in each region of Missouri. These specially trained officers are members of their local law enforcement agencies and provide a level of expertise to their agency and community with regards to terrorism prevention, response and mitigation. This grant program will provide increased capabilities across these mission areas.

# Objective

By combining specially trained officers with the proper mission specific equipment, this project will allow officers participating in the CTO Program to dramatically increase their ability to delay, divert, intercept, halt, apprehend, or secure threats and/or hazards.

This project addresses the gaps identified in the THIRA/State Preparedness Report (SPR), specifically as it applies to outreach to the fusion centers, Joint Terrorism Task Force (JTTF), and for the assignment of personnel for follow up interdiction and disruption.

This project will enhance the Missouri Counter Terrorism Officer Program's effectiveness at the local level by giving agencies the opportunity to acquire equipment uniquely focused on their terrorism prevention mission and locality. Items purchased through this opportunity will support the law enforcement officers involved in the CTO Program. Officers who are specially trained to prevent, respond to, and mitigate acts of terror is a homeland security initiative.

# Funding Instrument: Grant

#### **Eligible Applicants:**

To be eligible for this grant opportunity the agency must have staff participating in the CTO Program. Eligible applicants are listed in Appendix A. Only entities listed in Appendix A are eligible to apply.

To be eligible for SHSP funding, the applicant agency must be compliant with the following statutes, as applicable and must maintain compliance throughout the grant period of performance:

• <u>Section 320.271 RSMo</u>– Fire Department Registration Pursuant to <u>section 320.271 RSMo</u>, All fire protection districts, fire departments, and all volunteer fire protection associations as defined in section 320.300 shall complete and file with the state fire marshal within sixty days after January 1, 2008 and annually thereafter, a fire department registration form provided by the state fire marshal

#### • Section 590.650 RSMo- Vehicle Stops Report

Pursuant to <u>section 590.650.3 RSMo</u>, (1) every law enforcement agency shall compile the data described in subsection 2 for the calendar year into a report to the attorney general and (2) each law enforcement agency shall submit the report to the attorney general no later than March first of the following calendar year.

NOTE: It is the responsibility of the applicant to verify the submission of this report with the Attorney General's Office <u>prior</u> to submitting an application. Failure to submit the Racial Profiling Report will result in the automatic denial of the application. A copy of such report does not need to be submitted with the application.

• <u>Section 590.700 RSMo</u> – Written Policy on Recording of Custodial Interrogations Pursuant to <u>section 590.700.4 RSMo</u>, each law enforcement agency shall adopt a written policy to record custodial interrogations of persons suspected of committing or attempting to commit felony crimes as outlined in subsection 2 of this section and shall certify adoption of such policy when applying for any grants administered by the Department of Public Safety.

**NOTE:** It is the responsibility of the applicant to ensure the prescribed written policy is in place <u>prior</u> to submitting an application.

• <u>Section 43.544 RSMo</u> – Written Policy on Forwarding Intoxication-Related Traffic Offenses

Pursuant to <u>section 43.544.1 RSMo</u>, each law enforcement agency shall adopt a policy requiring arrest information for all intoxication-related traffic offenses be forwarded to the central repository as required by <u>section 43.503 RSMo</u> and shall certify adoption of such policy when applying for any grants administered by the Department of Public Safety.

# **NOTE:** It is the responsibility of the applicant to ensure the prescribed written policy is in place <u>prior</u> to submitting an application.

<u>Section 590.1265 RSMo</u> – Police Use of Force Transparency Act of 2021
 Pursuant to section <u>590.1265 RSMo</u> Use of force incidents reporting standards and
 procedures, publication of report data, analysis report. Each law enforcement agence

procedures, publication of report data, analysis report. Each law enforcement agency shall report data submitted under subsection 3 of this section to the department of public safety. For purposes of grant eligibility, law enforcement agencies will be considered non-compliant if they have not submitted Use of Force reports for three or months in the past twelve months. Each law enforcement agency shall certify compliance with Section 590.1265 RSMo when accepting any grants administered by the Department of Public Safety.

• <u>Section 43.505 RSMo</u> – National Incident-Based Reporting System (NIBRS) formerly Uniform Crime reporting (UCR)

Pursuant to <u>section 43.505 RSMo</u> Uniform Crime Reporting system – duties of department – violations, penalty: Each law enforcement agency in the state shall: (1) Submit crime incident reports to the department of public safety on forms or in the format prescribed by the department; and (2) Submit any other crime incident information which may be required by the department of public safety. *Agencies that are not compliant at the time of application will only be eligible for grant funds to assist the agency to become compliant.* For purposes of grant eligibility, law enforcement agencies will be considered non-compliant if they have not submitted MIBRS reports for three or more months in the past twelve months.

NOTE: Show Me Crime Reporting provides a no cost option for agencies to comply with Section 43.505 RSMo. Agencies that are not currently compliant with Section 43.505 RSMo will not be eligible to apply until they have registered with Show Me Crime Reporting and have begun submitting MIBRS reports. <u>https://showmecrime.mo.gov/CrimeReporting/MIBRSRegistration.html</u>

• <u>Section 590.030 RSMo</u> – Rap Back Program Participation

Pursuant to <u>section 590.030 RSMo</u>, all law enforcement agencies shall enroll in the state and federal Rap Back programs on or before January 1, 2022 and continue to remain enrolled. The law enforcement agency shall take all necessary steps to maintain officer enrollment for all officers commissioned with that agency in the Rap Back programs. An officer shall submit to being fingerprinted at any law enforcement agency upon commissioning and for as long as the officer is commissioned with that agency. Each law enforcement agency shall certify compliance with <u>section 590.030 RSMo</u> when accepting any grants administered by the Department of Public Safety.

The CTO equipment grant program is designed to specifically address gaps identified through the THIRA/SPR process completed by the Missouri Office of Homeland Security.

# **Other Eligibility Criteria**

#### National Incident Management System (NIMS) Implementation

Prior to allocation of any Federal preparedness awards in FY 2024, subrecipients must ensure and maintain adoption and implementation of NIMS, including implementation of important operational systems defined under NIMS, such as the Incident Command System (ICS). The list of objectives used for progress and achievement reporting is on FEMA's website at <u>NIMS</u> <u>Implementation and Training</u>.

### **Emergency Management Assistance Compact (EMAC) Membership**

In support of the National Preparedness Goal (the Goal), SHSP subrecipients must belong to, be in, or act as a temporary member of EMAC. All assets supported in part or entirely with FY 2024 SHSP funding must be readily deployable and NIMS-typed when possible to support emergency or disaster operations per existing EMAC agreements. In addition, funding may be used for the sustainment of core capabilities that, while they may not be physically deployable, support national response capabilities, such as Geographic/Geospatial Information Systems (GIS), interoperable communications systems, capabilities as defined under the Mitigation Mission Area of the Goal, and fusion centers.

#### **SHSP CTO Equipment Grant Funding Guidelines**

Subrecipients must comply with all the requirements in <u>2 C.F.R. Part 200</u> (*Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards*). Funding guidelines established within this section support the four mission areas—Prevention, Protection, Mitigation, and Response—and associated core capabilities within the Goal. Allowable investments made in support of national priorities, must have a nexus to terrorism preparedness and fall into the category of equipment aligned to building capability, closing capability gaps, and/or sustaining capabilities identified in the State THIRA/SPR.

#### **Multiple Purpose or Dual-Use of Funds**

For SHSP, many activities that support the achievement of core capabilities related to the national priorities and terrorism preparedness may simultaneously support enhanced preparedness for other hazards unrelated to acts of terrorism. However, all SHSP funded projects must assist subrecipients in achieving core capabilities related to preventing, preparing for, protecting against, or responding to acts of terrorism per section 2008(c) of the *Homeland Security Act of 2002* [6 U.S.C. § 609(c)].

#### **Funding Restrictions and Allowable Costs**

All costs charged to awards covered by this NOFO must comply with the Uniform Administrative Requirements, Cost Principles, and Audit Requirements at <u>2 C.F.R. Part 200</u>, unless otherwise indicated in the NOFO, the terms and conditions of the award, or the <u>Preparedness Grants Manual</u>. This includes that costs, among other requirements, must be incurred, and products and services must be delivered, within the period of performance of the award. *See* <u>2 C.F.R. § 200.403(h)</u> (referring to budget periods, which for FEMA awards under this program is the same as the period of performance).

Federal funds made available through this award may be used for the purpose set forth in this NOFO, the <u>Preparedness Grants Manual</u>, and the terms and conditions of the award and must be consistent with the statutory authority for the award. Award funds may not be used for matching funds for any other federal awards, lobbying, or intervention in federal regulatory or adjudicatory proceedings. In addition, federal funds may not be used to sue the Federal Government or any other government entity. See the <u>Preparedness Grants Manual</u> for more information on funding restrictions and allowable costs.

#### 1. Prohibitions on Expending FEMA Award Funds for Covered Telecommunications Equipment or Services

Subrecipients of FEMA federal financial assistance are subject to the prohibitions described in section 889 of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 (FY 2019 NDAA), Pub. L. No. 115-232 (2018) and 2 C.F.R. §§ 200.216, 200.3267, 200.471, and Appendix II to 2 C.F.R. Part 200. Beginning August 13, 2020, the statute – as it applies to FEMA recipients, subrecipients, and their contractors and subcontractors –

prohibits obligating or expending federal award funds on certain telecommunications and video surveillance products and contracting with certain entities for national security reasons.

Guidance is available at <u>FEMA Policy #405-143-1</u>, <u>Prohibition on Expending FEMA Award</u> <u>Funds for Covered Telecommunications Equipment or Services</u>.

Additional guidance is available at <u>Contract Provisions Guide: Navigating Appendix II to</u> <u>Part 200 – Contract Provisions for Non-Federal Entity Contracts Under Federal Awards</u> (fema.gov).

Effective August 13, 2020, FEMA recipients and subrecipients may not use any FEMA funds under open or new awards to:

- a. Procure or obtain any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology of any system;
- b. Enter into, extend, or renew a contract to procure or obtain any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology of any system; or
- c. Enter into, extend, or renew contracts with entities that use covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system.

#### I. Replacement Equipment and Services

FEMA grant funding may be permitted to procure replacement equipment and services impacted by this prohibition, provided the costs are otherwise consistent with the requirements of the NOFO and the <u>Preparedness Grants Manual</u>.

#### II. Definitions

Per section 889(f)(2)-(3) of the FY 2019 NDAA and 2 C.F.R. § 200.216, covered telecommunications equipment or services means:

- i. Telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation, (or any subsidiary or affiliate of such entities);
- For the purpose of public safety, security of Government facilities, physical security surveillance of critical infrastructure, and other national security purposes, video surveillance and telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, or Dahua Technology Company (or any subsidiary or affiliate of such entities);
- iii. Telecommunications or video surveillance services provided by such entities or using such equipment; or

iv. Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of Defense, in consultation with the Director of National Intelligence or the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or controlled by, or otherwise connected to, the People's Republic of China.

Examples of the types of products covered by this prohibition include phones, internet, video surveillance, and cloud servers when produced, provided, or used by the entities listed in the definition of "covered telecommunications equipment or services." See <u>2 C.F.R. § 200.471</u>.

#### **Allowable Costs:**

This grant only allows projects for equipment/supplies that will support the Counter Terrorism Officer (CTO) and their mission. The allowable equipment categories for SHSP are listed on the <u>Authorized Equipment List (AEL)</u>. Some equipment items require prior approval from FEMA/DPS/OHS before obligation or purchase of the items. Please reference the grant notes for each equipment item to ensure prior approval is not required or to ensure prior approval is obtained if necessary.

#### Allowable/Recommend Equipment:

- 03OE-02-TILA- Optics, Thermal Imaging and/or Light Amplification (no weapons mounted options) Night Vision
- 03OE-02-BNOC- Binoculars/Scopes (no weapons mounted options) Binoculars
- 06CC-01-CELL- Communications and Computing Device, Handheld Handheld, ultraportable communications devices
- 03OE-03-KTFA- Kit, First Aid, Trauma Type First Aid/Trauma Kits
- 01LE-02-ARMR Body Armor
- Other personal protective equipment (see Authorized Equipment List)
- 04HW-01-INHW Mobile Data Terminal (MDT)
- 03OE-07-SUAS- System, small unmanned aircraft (will require drone operator license) Drones, Small Unmanned Aircraft
  - o Only drones manufactured in the United States are allowable
    - List of United States manufactured drones that have been approved by the Department of Defense can be found here: <u>Blue UAS Cleared List</u>. \*Note: The drones on this list are only those that have been approved by the Department of Defense. Those on this list are not the only United States manufactured drones that are allowable.
  - <u>All drones require a waiver from the DHS/FEMA before purchase.</u> \*Note: Required information for the drone waiver is not required at the time of application submission but is required before the waiver request can be submitted to DHS/FEMA. At a minimum, the drone waiver will require the following information:

- Justification to describe the need for the drone with the primary focus on homeland security and Chemical, Biological, Radiological, Nuclear, Explosive (CBRNE)-nexus
- Detailed specifications for each piece of equipment/component of the drone to include the make, model, and operating weight
- Justification how the drone fits into state and local operational planning
- Examples of how the drone will be operationally deployed
- Justification how the drone will be used in non-emergency scenarios
- Civil Rights and Civil Liberties Policy(s) that align with: <u>Presidential</u> <u>Memorandum: Promoting Economic Competitiveness While Safeguarding</u> <u>Privacy, Civil Rights, and Civil Liberties in Domestic Use of Unmanned</u> <u>Aircraft Systems</u>. Policies must contain the following:
  - Privacy Section that includes provisions addressing the following:
    - Authorized Purposes
    - Data Collection
    - o Dissemination
    - PII Retention
    - o Policy Review
  - Civil Rights/Civil Liberties section that addresses the following:
    - Specific language that drone-collected data won't be used to monitor protected activities
    - Specific language that drone-collected data won't be used based on individual characteristics
    - Civil rights/civil liberties and privacy complaint and investigations
  - Accountability section that addresses the following:
    - Audit and oversight of subrecipient's drone program
    - Rules of conduct for personnel involved in the drone program

Some allowable equipment items have specific requirements to be eligible for funding. Those with specific requirements are listed below. <u>Please note, the items listed below are not the</u> <u>only eligible equipment items.</u>

• Interoperability Equipment (Portables/Handhelds, Mobiles, Repeaters, Base Stations, etc.)

All interoperable communications equipment must meet the Missouri Department of Public Safety, Office of the Director, DPS Grants <u>Radio Interoperability Guidelines</u>. The Missouri Interoperability Center (MIC) will review all communications equipment applications to ensure they comply with the <u>Radio Interoperability Guidelines</u>. <u>Applications that do not</u> <u>meet these guidelines will not be eligible for funding.</u>

NOTE: Agencies seeking any type of radio or radio-related accessory are encouraged to contact the Missouri Interoperability Center by phone at (573) 522-1714, (855) 466-7946 or by email at <u>moswin.sysadmin@dps.mo.gov</u> to ensure compliance with the Radio Interoperability Guidelines and the appropriate communication devices are purchased for the department's needs. The Missouri Interoperability Center staff can also provide helpful information regarding the department's ability to access the MOSWIN and how to articulate such within the grant application.

• Mobile Data Terminals (MDTs) / Mobile Data Computers (MDCs) Requirements

Agencies seeking funding for mobile data terminals should research the type of computer being requested. The Missouri Department of Public Safety is aware that non-ruggedized laptops and tablets are typically not durable enough for road patrol purposes and therefore not the best use of funds.

Body-Worn Cameras

Agencies seeking funding for Body-Worn Cameras (BWCs) must have policies and procedures in place related to equipment usage, data storage and access, privacy considerations, and training. Subrecipients of funding for Body-Worn Cameras must supply the Missouri Department of Public Safety with a copy of such policy(s) and procedure(s) at the time of claim submission.

Body Armor

Funds may be used to purchase body armor at any threat level designation, make, or model from any distributor or manufacturer, as long as the body armor has been tested and found to comply with the latest applicable National Institute of Justice (NIJ) ballistic or stab standards, which can be found online at <u>https://www.nij.gov/topics/technology/body-armor/Pages/standards.aspx</u>.

Body armor or armor vests must also be "uniquely fitted vests" which means protective (ballistic or stab-resistant) armor vests that conform to the individual wearer to provide the best possible fit and coverage, through a combination of:

Correctly sized panels and carrier, determined through appropriate measurement and
 Properly adjusted straps, harnesses, fasteners, flaps, or other adjustable features.

The requirement that body armor be "uniquely fitted" does not require body armor that is individually manufactured based on the measurements of an individual wearer.

In addition, body armor purchased must be made in the United States.

Agencies seeking funding for body armor are required to have a written "mandatory wear" policy in effect. There are no requirements regarding the nature of the policy other than it being a mandatory wear policy for all uniformed officers while on duty. Subrecipients of funding for body armor must supply the Missouri Department of Public Safety with a copy of such policy at the time of claim submission.

• License Plate Readers

Agencies purchasing license plate reader (LPR) equipment and technology with grant funds administered by the Missouri Department of Public Safety, must adhere to the following requirements:

- a. LPR vendors chosen by an agency must have an MOU on file with the MSHP Central Vendor File as developed and prescribed by the Missouri Department of Public Safety pursuant to 11 CSR 30-17.
- b. Prior to purchasing LPR services, the agency should verify the vendor's MOU status with the MSHP CJIS Division by emailing mshphelpdesk@mshp.dps.mo.gov.
- c. Share LPR data through the MoDEx process with statewide sharing platforms (i.e., MULES).
- d. Enable LPR data sharing with other Missouri Law Enforcement agencies and enforcement support entities within the selected vendor's software. Examples include, but are not limited to fusion centers, drug task forces, special investigations units, etc.
- e. Connect to the Missouri State Highway Patrol's Automated License Plate Reader (ALPR) File Transfer Protocol Access Program. This program provides the information necessary to provide a NCIC and/or MULES hit when used in conjunction with a License Plate Reader (LPR) device. An MOU must be on file with the Access Integrity Unit (AIU) for the vendor and the law enforcement agency and a registration process must be completed.
- f. Agency shall have a license plate reader policy and operation guideline prior to the implementation of LPRs. Reimbursements will not be made on the project until the policy has been provided to the Missouri Department of Public Safety.

If LPR will be installed on Missouri Department of Transportation right-of-way(s) agency must request installation through the Missouri Department of Public Safety. Once approved, agency

must adhere to the Missouri Department of Transportation's guidelines regarding installation of LPR's on Missouri Department of Transportation right-of-way(s).

### **Unallowable Costs**

- Per FEMA policy, the purchase of weapons and weapon accessories, including ammunition, is not allowed with SHSP funds.
- Grant funds may not be used for the purchase of equipment not approved by DHS/FEMA/DPS/OHS. Grant funds must comply with <u>FEMA Policy 207-22-0002</u>, <u>Prohibited or Controlled Equipment Under FEMA awards</u>, and may not be used for the purchase of the following equipment: firearms; ammunition; grenade launchers; bayonets; or weaponized aircraft, vessels, or vehicles of any kind with weapons installed.

# Administrative and National Policy Requirements

In addition to the requirements in this section and elsewhere in this NOFO, FEMA/DPS/OHS may place specific terms and conditions on individual awards in accordance with 2 C.F.R. Part 200.

# **DHS Standard Terms and Conditions**

All successful applicants for DHS grant and cooperative agreements are required to comply with DHS Standards Terms and Conditions, which are available online at: <u>DHS Standard Terms and</u> <u>Conditions</u>.

# **Ensuring the Protection of Civil Rights**

As the Nation works towards achieving the <u>National Preparedness Goal</u>, it is important to continue to protect the civil rights of individuals. Subrecipients must carry out their programs and activities, including those related to the building, sustainment, and delivery of core capabilities, in a manner that respects and ensures the protection of civil rights for protected populations.

Federal civil rights statutes, such as Section 504 of the Rehabilitation Act of 1973 and Title VI of the Civil Rights Act of 1964, along with DHS and FEMA regulations, prohibit discrimination on the basis of race, color, national origin, sex, religion, age, disability, limited English proficiency,

or economic status in connection with programs and activities receiving federal financial assistance from FEMA.
