

MONTHLY STATUS OFFENDER/NON-OFFENDER SECURE DETENTION MONITORING SURVEY

INSTRUCTIONS:

Please list all accused and adjudicated status offenders/non-offenders securely detained in your facility for any length of time during the reporting month. You do not need to list status offenders/non-offenders securely detained on allegations of delinquency (law violations if committed by an adult) nor do you need to list any securely detained juvenile adjudicated delinquent during the current term of probation even if the current allegation is a status offense. If your facility did not admit any status offenders/non-offenders for the month, check the box in the upper left corner of the survey.

- **Juvenile's ID Number or Initials:** Identify each juvenile by the unique number you assign at the time of admission or their initials. This should be the same ID method that is used to identify a juvenile's record within your facility.
- **Age:** List the age of the juvenile at the time of secure detention.
- **Gender/Race:** Indicate "M" for male and "F" for female. Indicators for race: (W) for White, (B) for Black or African American, (H) for Hispanic or Latino, (I) for American Indian, (A) for Asian, (HP) for Native Hawaiian or Other Pacific Islander, (O) for Other. A slash "/" may be used between indicators.
- **Offense:** List the most serious offense for which the youth was securely detained. Status offenses* are defined under 211.031.1(2) RSMo. Victims of child abuse and neglect **MAY NOT** be held in secure detention centers pursuant to 210.125.5 RSMo. Illegal aliens held under federal jurisdiction must also be reported on this survey. **Note that, by federal definition, a juvenile status offender cannot be upgraded to a delinquent offender by traditional contempt power, failure to appear, or for probation violation.*
- **Date/Time of Admission:** List the date and time (military or a.m./p.m.) the juvenile was admitted to your facility. Do not report any juveniles held over from a prior month if they were previously reported.
- **Date/Time of Release:** List the date and time (military or a.m./p.m.) the juvenile was released from your facility. If the juvenile has not been released at the time the survey is completed, leave this section blank.
- **Detained PRE-adjudication, POST-adjudication:** Check "PRE-Adjudicated" if the juvenile was accused of committing a status offense, but has not yet been adjudicated for that offense. Juveniles in secure detention awaiting their dispositional hearing are considered to be Pre-adjudicated. Check POST-Adjudicated" if a juvenile is securely detained or securely placed in your facility after having been adjudicated as a status offender and no pending allegations exist or the juvenile is only being held on allegations of violating a valid court order. **Adjudicated juveniles remaining in secure detention awaiting transfer are considered post-adjudicated. If a juvenile is held both before and after their dispositional hearing, report the juvenile as "Post-Adjudicated"**. Under federal regulation and state law, a juvenile charged under 211.031.1(2) RSMo shall not be securely detained in excess of 24 hours (excluding weekend/holidays) unless found to have violated a valid court order, at which time other regulations apply (see VCO Exception).
- **Detaining Jurisdiction (if different):** For out of circuit holds list the circuit #, county, or agency ordering the detention.
- **Out-of-State:** If a juvenile is not from Missouri, list the State ordering the detention.
- **Federal Ward:** If an immigrant juvenile is held under federal jurisdiction, check this column.
