Inquiry from Senator Emery – Steve Sokoloff

Senator Emery has expressed interest in having conversations with experts in the 911 field about funding and the possibility of using General Revenue Funds to support 911 services.

### **Subcommittee Reports**

- **Legislative Subcommittee Report**

Steve Hoskins gave an update on the legislative efforts for 911 funding at the request of Mike Hall. They have their Bill prepared to pre-file in both the House and the Senate. New proposed legislation is enabling legislation allowing counties to put a new form of tax that would include any and all devices capable of contacting 911 up for citizen vote. They are hopeful that things will move forward successfully this year.

- **Professional Standards – Recommend Training Requests**

Jim Person gave a brief review on the 36 courses that were submitted for approval. Mr. Person recommends the individual courses on the lists down to those submitted by the DSS Corporations be approved. He would like to examine the 18 courses submitted by DSS more closely due to the large number of hours they are requesting. The remaining 18 courses cannot be approved at this time due to no quorum present but will be sent out to the committee via email for vote of approval.
