Hearings on this year's 911 legislation are taking place. Plans are nearly finalized for the spring Communications Conference to be held at Union Station in St. Louis on March 4 - 7, 2018.

Old Business

Missouri 911 Modernization and Improvement Report for Discussion

Extensive and detailed conversation was conducted to make sure the report was a document the committee could unanimously support without reservations. Points of clarification included but were not limited to:

- Regional Coordination Centers are not a single PSAP for a region. They can be a PSAP, but that is not a mandate if there is a functioning system in place like MARC in Kansas City. The number 11 was established around the areas or organization for the Highway Patrol, Department of Health and Homeland Security Regions (A Rural, A Urban-KC, B, C, St. Louis, D, E, F, G, H, I). The wording of the report was carefully crafted to guarantee that we in no way were implying it is appropriate at this time for Missouri to have only 11 PSAPs. The Board in fact made it clear that at this time, it would be inappropriate to give a specific number of PSAPs that would be appropriate for our state. There are just simply too many disparate funding sources, equipment needs, and personnel resources at current centers for the state mandate a single method of management and consolidation.
- While there are some regional ESINet capabilities, there is no Statewide ESINet. This single action would make the most impact for all citizens and visitors to Missouri.
- An ESINet is not the same thing as FirstNet that the Missouri Interoperable Center has been working with. ESINet brings 911 calls in and distributes them to appropriate centers. FirstNet allows First responders outgoing calls to connect as a first priority on communication channels.
- Appending the raw data from the survey was considered, but rejected. Questions were posed in open format so that all felt free to answer as they felt appropriate. Because of this, raw data can be easily misinterpreted. Legislators wanting specific information can contact OHS and will be given their region's data if it was supplied.

After complete, detailed discussion and revision, the Board felt it prudent to give their endorsement to the DPS report to be presented to the legislature so that bills being introduced in this session would be able to use this report to document the state's need.

Alan Wells moved the 911 Service Board endorse the Missouri 911 Modernization and Improvement Report as amended. The Motion was seconded by Sheriff Stephen Korte and **approved by unanimous roll call vote.**

New Business

<u>Request from the Office of Administration regarding PSAPs assisting in the 2020 Census</u> – Mike Dierkes

OA asked if the PSAPs of the state were in a position to assist in the 2020 Census by giving them access to their GIS data. After discussion, it was determined, the data available to PSAPs, OA has already. As we don't necessarily have access to connect mailing addresses to mobile devices, PSAPs were unlikely to be able to provide useful data.

Open Discussion

Designation of 911 Coordinator – Mike Dierkes

The Service Board is now also charged with appointing the 911 Coordinator for the state of Missouri. However, we still have no funding for said position and no established criteria. Lisa Schlottach and Sonny Saxton will try to research the job description for 911 Coordinator from other states so that we can discuss at a future meeting. Legislation being proposed will provide the funding needed to hire a specialist for this position.

Alan Wells moved that Mike Dierkes serve as Interim 911 Coordinator until the board has time to fully research their needs and legislation can provide potential payroll. The Motion was seconded by Lisa Schlottach and approved by unanimous roll call vote.

Next Meeting

The next meeting is very tentatively scheduled for June 6, 2018 pending movement on legislation.
