Personnel

Overtime

This grant allows for overtime costs for the purpose of Emergency Medical Services (EMS) personnel deployment for coronavirus vaccination administration activities in the State of Missouri.

Equipment

This grant allows for equipment (personal protective equipment) purchases for the purpose of Emergency Medical Services (EMS) deployment for coronavirus vaccination administration activities in the State of Missouri.

**Equipment items over \$1,000 should receive pre-approval from the Missouri Department of Public Safety (DPS) before purchase. Equipment items that are submitted for reimbursement without pre-approval may be deemed unallowable.

Supplies

This grant allows for supply purchases, such as gloves, masks, and sanitizer for the purpose of Emergency Medical Services (EMS) deployment for coronavirus vaccination administration activities in the State of Missouri.

Travel

This grant allows for mileage expenses at the state mileage rate for the purpose of Emergency Medical Services (EMS) deployment to and from coronavirus vaccination administration activities in the State of Missouri.

Unallowable Costs

- Expenses that are eligible to be charged to a patient or their health insurance are not allowable toward the FY 2020 Emergency Medical Services COVID-19 Relief Funding
- Expenses that have been reimbursed through other federal funding sources

Supplanting

Federal grant guidance prohibits supplanting, which is defined as deliberately reallocating state, local or agency funds because of the existence of the federal funds. Federal funds must increase or supplement the funding available for approved projects.
