Introduction:

The Missouri Department of Public Safety is pleased to announce the funding opportunity for the Streetlight Grant Program made available through Missouri House Bill 20 section 20.994.

Program Description:

The Streetlight Grant Program is designed to enhance community safety and well-being by providing financial support exclusively for the installation and electricity connection of streetlights. Recognizing the critical role that proper lighting plays in crime prevention and pedestrian safety, this program offers the resources needed to illuminate the City of Arnold's streets effectively.

This program serves as a valuable resource for communities located in the City of Arnold looking to enhance their infrastructure, create safer environments, and improve residents' quality of life. The Streetlight Grant Program specifically targets installation and connection costs, empowering communities within the City of Arnold to make concrete progress toward a brighter, safer future.

Period of Performance: 8.5 months

Projected Period of Performance Start Date: 10/01/2024

Projected Period of Performance End Date: 06/15/2025

Funding Instrument: Grant

Maximum Award: \$300,000

Match Requirement: 50% match/cost share requirement (Cash [Hard] Match or In-kind [Soft])

Cash Match (Hard): Cash or hard match includes cash spent for project-related costs.

<u>In-kind Match (Soft)</u>: In-kind or soft match refers to contributions of the reasonable value of property or services in lieu of cash that benefit this project or program. In-kind match MUST be directly related to the project and may be retroactive to March 2020.

Cost share can be calculated using the formula below:

Step 1: Calculating Total Project Costs based on a 50/50 match.

<u>Award Amount</u> = Total Project Costs Match Percentage

Step 2: Calculating Subrecipient's Match Percentage

Subrecipient's Match Percentage x Project Costs = Required Match

Example 1: $\frac{$100,000}{50\%}$ = \$200,000 Total Project Costs

50% x \$200,000 = \$100,000 Subrecipient Cost Share

Example 2: $\frac{$200,000}{50\%} = $400,000 \text{ Total Project Costs}$

50% x \$400,000 = \$200,000 Subrecipient Cost Share

Eligible Applicants:

A city with more than 20,000 residents but fewer than 23,000 residents and located in a county with more than 200,000 but fewer than 230,000 residents.

Eligible Cost Items:

The objective of the Missouri Department of Public Safety in awarding Streetlight Grant Program funding to upgrade streetlights, thereby increasing the safety of that city.

Unallowable Cost Items:

Personnel/Benefit Costs
Travel/Training Costs
Lobbying
State and Local Sales Taxes
